The approach and model adopted has been developed to integrate the approach to service delivery, meet national IAPT access requirements and, amongst other things, address the waiting time pressures and capacity constraints which have historically arisen in parts of the IAPT treatment pathway, and which are envisaged to reoccur due to increasing numbers and complexity of patients following the impacts of COVID-19.

It is anticipated that the bringing together previously disparate services under the scope of one single contract awarded to and managed by CNTW with a single point of access hub, will deliver significant benefits including:
