One integrated urgent care service model delivered across 4 urgent care locations in premises in James Cook University Hospital, Redcar Primary Care Hospital, University Hospital of North Tees, University Hospital of Hartlepool

The contract term is for an initial period of 5 years commencing on 01 April 2024, with an option to extend for a further 5 years at the discretion of the Contracting Authority and subject to satisfactory contractual and financial performance.

The closing date for submission of tenders was by 12 noon 12 October 2023.

### **Additional information**

Firstly, the "Transfer of Undertakings (Protection of Employment) Regulations 2006" as amended by the "Collective Redundancies and Transfer of Undertaking (Protection of Employment) (Amendment) Regulation 2014" (TUPE) may apply to this contract.
