This contract will be advertised and procured based on a 2-year contract period with the option to extend for an additional 1 year. The expected value for the award is £269,338 for the 2-year contract period fully inclusive of any applicable VAT.

Additional funds may become available during the life of this contract, and should such

funds become available the Commissioner reserves the right to extend the contract into a Third Year. At this stage we cannot confirm whether additional funds will become available or the value of such funding, however we anticipate that such funding could be between £0 - £300k, a maximum indicative total contract value of £569,338 over the full 3 years.
