Hull City Council (The Authority) is seeking tenders from organisations to provide: Maintenance, Servicing & Upgrades of Controlled Entry, Magnetic Locks, Automated Systems, Roller Shutters and Car Park Barriers. The tender is an open tender of a one stage process. The contract is anticipated to commence 1 June 2026 ending by 31st May 2029, with an option to extend for a period or periods of up to a maximum of 24 months. The Authority has estimated the value of the services to be approximately £750,000 per annum.
