Following on, the contractor is also required to identify the mark-up to be applied against materials and where required plant. The contractor will be required to provide VAT Invoices as proof of purchase/ownership.

This framework will be for a 3 year term. The Trust has the option to extend on 2 plus 2 years basis up to a maximum of 7 years - 7 years in total (3+2+2).

We will appoint no more than 5 suppliers.

There is a provision for Supplier's site visit during the tender publication period, these are mandatory for the suppliers considering submitting ITT responses.
