Critical and Non-Critical pre and secondary filters 600 filter to change.

Critical pre filters 296 filters to change.

Critical and Non-Critical pre and secondary filters 600 filter to change.

Critical pre filters 296 filters to change.

All 336 belts used within the AHUs on site are to be changed annually (every 365 days) in line with the second of the Critical and Non-Critical pre and secondary filters changes.
