Tenderers who were seeking admission as a new entrant to the DFA were required to complete the same process as the original competition to ensure equal treatment and transparency. PLEASE NOTE: This opening (October / November 2023) was the last opening of the DFA. The DFA will not be re-opened for New Entrants in 2024 or 2025. The DFA's provision for a 12 month extension option until 31st December 2025 is still applicable (subject to BHSCT approval).
