The Architect will act as 'Lead consultant' and Principal Designer for the Architectural Design team, and shall provide, or procure a team of Sub-Consultants for the services outlined below and in the Annex 1-6. The Lead Consultant shall ensure the services as outlined in Annex 1-6, perform and deliver services in line with the RIBA Plan of Work 2020 and shall carry out the services required of the design team and provide the required and necessary skills
