1.3 Northampton College is inviting providers to tender to deliver full qualifications at a variety of levels. Partnership tenders should complement our subcontracting policy, with the aim of adding strategic value to existing college provision and enhancing the quality, range and geographical coverage of the College's Adult Education Budget provision.

The College's priority for sub-contracting is to enhance opportunities and access for learners through maintaining distance learning provision for adult students at scale, thus enabling learners who may not otherwise be able to access college or funded provision to do so.

Within our subcontracting portfolio, the curriculum priority will continue to be Health and Care, where many learners wish to enhance their portfolio of skills flexibly through distance learning.
