#### **Explanation:**

This purchase is an upgrade to an existing Real-Time Digital Simulator (RTDS) at the PNDC.

This upgrade is required to enhance the functionality of the RTDS to support the growing pipeline of projects that make use of the simulator.

The main reasons why an upgrade of existing equipment is required is stated below:

- 1. This is an upgrade of existing capability, meaning that a supply of equipment from a different manufacturer is not compatible.
- 2. RTDS models created over an extended period of time by University staff and students are compatible with the upgraded hardware. Procuring a simulator from a different supplier means that these models will be obsolete and new models need to be created which requires significant effort and investment.
- 3. The university have developed interfaces between the RTDS and external test equipment. Procuring a simulator from a different supplier would require redevelopment of these interfaces.
- 4. Significant savings are achieved through part exchange of the existing hardware.
