NHS South East London Clinical Commissioning Group (SEL CCG) (Bromley) currently commissions two Urgent Treatment Centres (UTCs) located at the Princess Royal University Hospital (PRUH) and Beckenham Beacon Hospital. It is expected that the contract will be procured with a term of no less than 5 years and based on the NHS Standard Contract terms and conditions. The indicative value for the total proposed contract is £6,500,000 per annum (£32,500,000 over 5 years), excluding VAT.
