After market research and a review of a number of public sector framework agreements there was a single supplier found that could provide all of the modules without bespokeing and who could satisfy the interface requirements.

As such we will be awarding a contract via Direct Award under the Crown Commercial Services G-Cloud 13 framework to Elcom Systems Limited.
