Both Wandsworth Borough Council and the London Borough of Richmond Upon Thames Arboriculture Maintenance Services contracts are due to expire on 31 March 2026 and require timely retendering, with tendering commencing in early June 2025.

The contracts relate to Arboriculture Services which include, but are not limited to: Tree Planting, Tree Pruning, Tree Felling, Young Tree Maintenance, Stump Grinding, Basal Growth, Climbing Tree Inspections and Emergency Works.

In Wandsworth, the total annual value of these contracts is circa £1 million. The London Borough of Richmond annual contract value is circa £600,000.
