Health Education England (HEE - the Commissioner) are issuing this Prior Information Notice to make the market aware of a future tendering opportunity. HEE previously issued a notice regarding the same project with the intention to commence the tender exercise in January 2021 – due to the current pandemic and the strain this has placed on a number of organisations, especially those within London, a decision has been made to stall this procurement and instead this will now commence in mid March.
