The Typhoon Delivery Team, part of the UK Ministry of Defence, intends to award a contract to Airbus Defence and Space Ltd (Newport) who designed and implemented the Local Key Management System (LKMS). The extant contract for support to this system is soon due to expire, therefore there is a requirement for a follow-on support contract to be placed.
- 2.
