The aim of this procurement is to upskill practitioners, enabling them to deliver evidence-based reflective parenting interventions in their local area to better support local families in improving the quality of parent-infant relationships.

It is desired that through this training, practitioners are upskilled in how to deliver a reflective parenting programme, resulting in more of such programmes being delivered across the 75 LAs. As there are already developed, evidence-based programmes within the market, we are seeking to purchasing an 'off the shelf' product.
