Nature and extent of the modifications (with indication of possible earlier changes to the contract):

1) The Green Waste Treatment Contract was originally awarded to Land Network (Melton) Ltd, as published in the 'Contract Award Notice'- but within a very short period of time (approx. 1 month) they withdrew from the Contract. This necessitated Rutland County

Council to award the Contract to the 2nd ranked bidder which was Mid-UK Recycle in July 2017; and New Earth Solutions (West) Ltd T/A Mid UK Recycling, acquired Mid UK Recycling on 12th June 2019.

2) 24 month contract extension (01.04.2022 - 31.03.2024)

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

24 month contract extension during the Covid pandemic, to facilitate the tender of a new consolidated waste contract by 1st April 2024. Under Regulation 72 (1)(b) of the Public Contract Regulations.
