The Ministry of Defence (MoD) is considering future options for the development of Assured alternative Position, Navigation & Timing (PNT) technologies through the Alternative Navigation (Alt Nav) Project - Assessment Phase (AP).

The purpose of this PIN is to:

- Make industry aware of an Industry Day happening at MOD Abbey Wood on 1st March 2024.
