This includes accounting, assurance, business and ethics training to a 'chartered' level. The qualification is credit rated at Level 11 on the Scottish Credit and Qualifications Framework (SCQF).

This qualification allows for the training of both graduate and entry level trainees in a hybrid method including providing face to face teaching across locations in Glasgow and Edinburgh.
