The extension is legally allowed under the terms of the call-off contract and covers the period between January 2024 and July 2025.

AMS is the sole supplier under the CCS PSR Framework and the NDA Group is lawfully allowed under the current T&Cs to have an 18 month extension of the call-off contracts placed by each Operating Company of the NDA Group.
