In addition to delivering services at the above depots it will be expected that roadside assistance services will be required as part of this contract.

- Response time to call outs within the boundaries of Stockport and Rochdale within 45 minutes
- Fleet inspections in accordance with set inspection regimes i.e. fortnightly inspections.
