Germline molecular genetics services for diagnostic and predictive testing for a wide range of genetic conditions including hereditary cancers, blood disorders, cardiac and lipid disorders. Somatic molecular services are carried out on a range of cancers including breast, colorectal, gynaecological, melanoma, sarcoma and blood (list not exhaustive). Molecular diagnostic testing takes place throughout a person's lifetime from preimplantation genetic diagnosis, prenatal screening/testing, new born screening as well as testing for adult onset conditions and the technologies and methodologies are constantly evolving with new improved instrumentation and testing pathways continuously being made available.. . Business Services Organisation (BSO) Procurement and Logistics Service (PaLS), on behalf of the Belfast Health and Social Care Trust (BHSCT), is establishing a Dynamic Purchasing System (DPS) for the procurement of molecular diagnostic equipment, reagents, consumables and other associated products for delivery of a modern molecular diagnostic service providing molecular and cytogenetic testing for rare genetic disorders/syndromes, hereditary cancers, somatic cancers and germline haematological disorders (list not exhaustive).
