This urgent requirement is in response to the COVID -19 outbreak. A direct award has been made due to extreme urgency under current public procurement regulations using regulation 32(2)(c) to support reduced testing turnaround times which are critical in the current outbreak and increase capacity for Covid 19 testing.,
