BBC staff require access to rental vehicles used for various operational or production reasons. BBC staff are able to hire such vehicles where public transport is not appropriate, in accordance with internal policy.

Vehicles will be available for hire via an online booking tool embedded on the BBC intranet, supported by offline support.
