We also consider that GPs remain best placed to respond appropriately to the findings of the NHS Health Check and provide the best follow-on advice and/or treatment to the patient depending on the results.

extensions, each of a year.

The contract will have a maximum annual value of £300,000 and at the proposed revised tariff of £24.09, this would give scope to fund approximately 12,500 health checks per annum.
