However, it is anticipated that the District Council will collect around 4000 tonnes per annum of Garden Waste. The successful Service provider will be required to place a storage container at South Hams District Council's waste transfer facility in Devon, and collect the container when ready for collection. The Service provider shall then transport the collected garden waste to their composting point where the waste shall be composted to standards set by PAS 100.
