- 3 – Quantifying risk and other uplifts
- 4 – Assisting TfW in quantifying the useful economic lives of the assets
- 5 – Assisting TfW in quantifying the remaining useful economic life of the assets
- 6 – Undertaking an annual adjustment to the asset value
