Blackpool Council is seeking to appoint suitable providers to deliver short break services for children and young people who: • have a disability and/or additional needs • are aged between 0-18 years (or 19 while still attending school) • live within the Blackpool Council boundary • require support to access social, play and leisure opportunities. Short break provision can range from a few hours a week to an allocated number of overnight breaks per year.
