Purchase and implementation of a new module.

### **VII.2.2) Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

This is a new module within Liquid Logic LCS. The Childrens Portal is only available from Liquid Logic and integrates with the currently invested and implemented LCS and EHM systems.

The additional module could not have been provided by an alternate contractor as it would not be operable with the existing system and duplicating this would be significant inconvenience and duplication of costs.
