There is no other organisation for which so many books and articles have been written about Lean Thinking, and added to this the remarkable offer Toyota make to open their doors and share their thinking, expertise and practices. The programme provides many in-depth site tours, with detailed explanations provided through expert coaches at the point of observation, all of which could not be obtained elsewhere. There are also Lean simulation exercises to prepare the clients for the changes they will make at their own facilities.

It is the opinion of Welsh Government that the contract in question satisfies the requirement of Regulation 32 Use of the negotiated procedure without prior publication as the only comprehensive provision of this service can be provided by Toyota.
