The successful provider will be able to meet the following requirements and ways of working.

- Provide an experienced Speech and Language practitioner with experience of working with young people 16 – 21 who will be seconded into a multi professional team to work collaboratively with other professionals to develop Individual care packages focused on independence and resilience building.
- The worker would need to receive clinical supervision from the provider as well as day to day line management from the Staying Put team leader
- This is an ambitious and new piece of work so there would be an element of learning as a team. The service provider will report on key learning as part of this process.
- A thorough understanding of DLD and broad language and communication needs is important, as well as the ability to train and support others to develop a working understanding.
- The service will be needs led, and not dependant on diagnosis. The Speech and Language Therapist, as part of the wider team will deliver in a range of community settings and in young people's homes.
