Background

Since Headteacher Andrew O'Neill took up his post in September 2016 the school has been radically transformed. Then girls' school Sion-Manning, it was undersubscribed, buildings neglected and set to close. Andrew has overhauled the school, doubling the pupil numbers from a low of under 400 to now 820 (840 from September 2023) and securing this summer GCSE results in the top 5% nationally.
