The purpose of the engagement is to:

- Understand viable delivery approaches and timescales
- Support a fair, transparent and proportionate procurement process

Aster Group intends to establish a Light Touch Framework Agreement with suitably qualified Providers for the provision of Chartered Institute of Housing (CIH) Level 4 and Level 5 Housing Management Qualifications to support the development of Senior and Executive Leaders within a Social Housing context.

The proposed requirement will include:

\*CIH Level 4 Certificate for Senior Housing Managers

\*CIH Level 5 Diploma for Senior Housing Executives

The procurement is expected to include flexible Delivery Models which may comprise:

\*Online with virtual tutor led sessions

\*On-line

\*Open and closed cohorts

The successful provider(s) will be required to demonstrate the capacity to enrol learners and commence delivery by 08 June 2026.
