The appointed provider will be responsible for delivering a full range of HR services, including but not limited to:

- Recruitment, onboarding, and induction support
- Employee relations and case management e.g. disciplinary matters
- Policy review, development, and implementation
- Employment law and compliance advice
- Absence management and performance management support
- HR systems support, reporting, and analytics
- Ad hoc HR advisory services to senior management and line managers, including strategic advice to Board and senior managers.
- Proactive support for staff learning and development
- Periodic in person visits to HBLB office
