The tender process will consist of two stages for each Project: an Enhanced Pre-Qualification (EPQ) stage and an Invitation to Tender (ITT) stage, resulting in the selection of preferred bidders. Any bidder wishing to participate in the EPQ stage for any Project, must express their interest as per the requirements in the EPQ documentation.
