In addition to working on non-operational sites it is a requirement that the Contractor must be able to work on live gas sites without direct supervision from WWU personnel. The competencies stated below are mandatory.

In order to maintain safe working conditions, WWU operates a system of Safe Control of Operations (SCO), which specify the procedures to be followed on various sites and/or for certain operations. All operatives working on live gas sites will be required to hold the appropriate SCO qualification.

All contractor operatives will be required to hold a current and valid SHEA (Gas) passport.
