One of the primary objectives is to support and enhance Police operations and evidence gathering to assist with the provision of a safe and secure environment within the borough and to support the efficient detection and prosecution of criminal and anti-social behaviour. The service provider must work collaboratively and cooperatively with Greater Manchester Police (GMP) during the contract period.

The Council's surveillance cameras will also support civil contingency duties and will from time to time be required to observe and report live community environmental conditions on request.
