An alternative supplier was identified via market research and verified via conversations with other Trusts to understand the pricing structure and ways of working. GlucoRX presented a huge saving for NELFT and when the meters were reviewed by the medical team, they were deemed appropriate for use especially as they meet the set regulatory requirements for Blood Glucose testing, and can provide a product that tests for both Glucose and Ketones in one device, which will streamline processes across the Trust.
