The software will be deployed nationally via network policies managed by DHCW, in close collaboration with local Health Board IT teams, guaranteeing seamless access for users on NHS Wales-issued devices. Additionally, the solution must support installation on non-networked machines where required, enabling flexibility for diverse user environments. DHCW requires access to the resource but does not intend to host it directly, ensuring that the tool remains accessible and centrally managed without local hosting responsibilities.
