Network Rail will require supply of haulage services from the external supply chain covering locomotives, drivers, ground staff, loads examiners, shunting and wagons. Haulage services will operate, as currently, under the supplier's safety case on the network under an Unregulated Track Access Agreement.

The services will run nationally and are likely to include a requirement to serve areas of the network not directly under Network Rail's purview (such as High Speed 1 (HS1), Transport for Wales (TFW), Transport for London (TFL) and HS2), subject to appropriate licenses and agreements being in place.

Any contract will have flexibility built-in to alter volumes annually, within specified limits and detailed plans will be developed on a rolling basis and confirmed/ called-off via the Employer's train planning system.
