North of England Commissioning Support (NECS) worked for, and on behalf of, NHS England - North West and NHS Lancashire and South Cumbria Integrated Care Board who wished to commission Alternative Provider Medical Services to be delivered from Waterloo House Surgery, Millom, Cumbria and Central Lakes Medical Practice (Ambleside and Hawkshead).

The basic principles that mirror those of the open procedure were followed for this procurement to test the capacity, capability, and technical competence of providers in accordance with the Light Touch Regime within The Public Contracts Regulations 2015 (as

amended), ensuring a fair, open and transparent process in accordance with NHS (Procurement, Patient Choice and Competition) (No. 2) Regulations 2013.

Under the Public Services (Social Value) Act 2012 the Contracting Authority must consider:
