**II.2.4) Description of the procurement**

Hertfordshire County Council (the Council) is seeking a suitably qualified Contractor to supply school milk to various establishments throughout Hertfordshire and the surrounding area. The majority of the requirement will be 189ml size recyclable poly bottles of milk supplied with biodegradable straws for nursery and infant school children. However, there will be the requirement for staffroom and kitchen milk at some establishments. School milk, on the present Contract, is currently supplied to 85% of schools across Hertfordshire in 189ml recyclable poly bottles with biodegradable straws. For guidance only, the annual spend is currently approximately £800,000 pa. This spend includes a small value for staff room and kitchen milk which is also supplied on the current Contract. The estimated total value of the Contract is stated in II.1.5) of this notice and is for the initial term inclusive of the approximate value for extensions. The Contract will be awarded for an initial term of two years, with the option to extend the Contract up to two further years. Please note that the contract requirements will be subject to available financial resources, supplier performance and flexibility to meet changing demands.
