This process was undertaken by NHS COECPC and was concluded in December 2019. This process failed to receive any appropriate bids and consequently awarded no contracts for Doncaster and Bassetlaw. The Trust will now enter into contracts with local providers, each contract to be negotiated and awarded separately.
