Due to unforeseen circumstances with their manufacturer as a result of non-compliance to Medical Device Regulation

(MRD) moving from IVD to IVDR compliance, Aquilant were granted a reasonable amount of time to successfully rectify this. Having resolved this earlier than anticipated, Aquilant can now commence their participation in the renewal contract 4440428 under Lot 1, and close this contract earlier than the extended date.
