The Secretary of State for Defence, acting by the Defence General Munitions Team (DGM PT), intends to enter into a contract with IPT Ltd (the Supplier) for the procurement of CEOFE Type B1A. The estimated total value of the procurement is £42,169.50 ex-VAT.
