## **II.2.4) Description of the procurement**

The priorities for Shropshire's Draft Health & Wellbeing Strategy refresh 2022-2027 are focussed on taking a whole population health approach to delivering care, alongside the draft Shropshire Plan 2022-2025 which puts supporting of independence a key priority.

To achieve these priorities, actions will include delivering appropriate health and care services, and key to this taking primary preventative action and support for those on waiting lists, which will involve those pre and post intervention. In addition, the Council's Corporate Plan priorities include 'Care for those in need at any age' and 'More people with a suitable home' which means that people should be enabled to be as independent as they can be in a home suitable for their needs. The availability of an Independent Living Centre service will support these priorities through helping to increase the availability and use of aids and adaptations through promotion and signposting, as well as its core activity of undertaking occupational therapy assessments, or 'consultations', for adaptations and equipment.

Shropshire Council wishes to contract with an organisation which can help it to achieve these aims through the following elements:

1.Provision of a Core Independent Living Centre Service

2.Provision of an Independent Living Worker/Facilitator service to provide rapid and intensive support and practical assistance for people with complex 'independent living' needs

Funding for this contract is capped at £293,500 per annum (Elements 1 and 2 aggregated) although up to an additional £30,000 per annum may be made available to expand Element 2 at the discretion of the Council.

As a public authority, in line with the Public Services (Social Value) Act 2012 the Council has due regard to economic, social, and environmental well-being in Shropshire.

Accordingly, the Council wishes to maximise the social and economic impact of the proposed solution in accordance with its Social Value Framework
