- o Infrastructure to supply & install 12 cameras to enable the digitalisation of 2 clean labs which connect to the immersive room. This will need to be invoiced and supplied before 31/03/2024 for this part of the contract.
- o Deliver, install and complete the whole contract on site by 31/08/24.
- o Include an option for a portable immersive space.
