We wish to establish a framework of works contractors for Traditional, and Design & Build projects, who will be invited to tender under mini competition, for works contained in the Council's programme of new buildings, extensions, and repair and refurbishment of its building assets.

Where the information provided does not meet item (i) but there is an improving trend East Lothian Council may consider items (ii) and (iii).

Lots 1-5 Traditional- Work Packages will be awarded as a result of Mini Competition based on lowest price only.

Lots 6-9 Design and Build- Work Packages will be awarded as a result of Mini Competition based on quality and price. The weighting of quality / price criteria will vary between projects and will be specific to the individual project being tendered. It is envisaged the

weightings will be in the region of; Quality 10% - 15% and Price 85% - 90%.ELC reserves the right to vary these ratios.
