- An all age phlebotomy service, accessible from primary care and 7-day services, which will provide community-based clinics in multiple Oldham locations and offer blood taking services at home for house bound/ clinically indicated patients.
- A community based anti-coagulation management service, designed to directly support patients on warfarin therapy as well as clinicians managing patients in primary care on DOACs
- Delivery of the national Latent Tuberculosis Infection (LTBI) screening programme for Oldham, working locally to the national specification.
