The care home services forming part of the Flexible Framework are regulated by the Care Inspectorate in Scotland and must be registered with them as Care Home Service for Adults.

Care home services will support people to achieve the best possible quality of life, in terms of their personal aspirations, choices and abilities, where people's needs are best met within a residential setting for adults.
